A child tells me about abuse  
(Disclosure)

Tell the child you **cannot keep** this a secret if  
you think the Child is not safe

**LISTEN** to the child  
BE Careful of body language

Wherever possible, make notes of what the  
child says, **DO NOT ASK YES / NO** questions

Where possible write concern on a concern  
sheet  
(Located beside photocopier)

As quickly as possible take your concern to  
Designated Safeguarding Lead who is:  
**Miss Yvonne Craig**  
**Head Teacher**

If the concern is regarding the head teacher  
Miss Yvonne Craig contact the (Chair of  
Governors)  
**Mrs Karen Mumberson**

If the Designated Safety lead is unavailable  
contact the Deputy Designated Safety Lead  
who is  
**Mrs Shelley McGlasson**

If the Deputy Designated Safety lead is  
unavailable report your concern to one of the  
other Safeguarding Team members  
**Mrs Helen Chilton**  
**Mrs Kay Dawson**  
**Mrs Eileen Ditchburn**
