What are Special Educational Needs?

The Special Educational Needs Code of Practice states that a child or young person has SEN if they have a learning difficulty or disability which calls for special educational provision to be made for him or her.

A child may have a special education need (SEND) if they require additional or different provision to support them in their learning. The school will assess your child to identify their strengths, needs and give extra support if needed. If your child is on the SEND register they may be at one of the three stages:

School Support: extra help in class

Early Help: advice from outside specialists

EHCP: needs are complex and severe.

A child may have difficulty in reading, writing or mathematics, understanding others and expressing themselves, sensory perception or physical mobility or difficulties communicating with others. These difficulties can cause barriers to the child's learning. For some children this may be a temporary difficulty, while others may have a long term need for special help.

How will EJS offer support and help to my child?

At EJS we focus on the child or young person as a whole, not their SEND label and integration is key to our approach. EJS is a very inclusive school with a long standing strong commitment to meeting the needs of all our pupils. The SEND team work together with all staff members to ensure that lessons include a range of tasks and ways of working, and extra curricula activities that are accessible to all pupils. We also provide a range of additional support for pupils who have been identified as having a specific need.



What interventions do EJS offer?

- Small learning groups with particular foci drawn from the needs of the children
- In-class support across the curriculum.
- Language and English groups (4-10 pupils)
- Maths groups (4-10 pupils)
- Nurture Group
- Specific intervention programmes – Reading Intervention, Springboard, Success in Spelling, Toe by Toe, Maths Recovery etc.
- Family Learning
- Family support from the Senior Learning Mentor
- Social skills groups – Learning To Get Along
- Behaviour, emotional, social development projects – Anger Management, Bereavement, Lego Therapy
- Risk and Safety Groups – Kidsafe and E-Safety
- Support with homework.
- Mindfulness, Yoga, Relaxation

Who may be involved with my child from outside of the school?

Experts from outside agencies may be asked to assess your child's needs if they continue to have difficulties or if further assessment is required. The SENDCo may ask for your permission to seek additional advice from outside specialists such as Barnardos, Young Carers, health professionals, specialist teachers or educational psychologists who would:

- Carry out further assessment of your child's needs
- Provide advice to schools on how to best support your child
- Suggest resources that would help your child make progress

Parents are wherever possible offered the opportunity to meet with these professionals during SEN reviews to discuss the results of their assessment.

What is an Education, Health and Care Plan?

If your child's needs are very complex the school may ask the local authority, in collaboration with you as the parent or carer, to carry out an education, health and care needs assessment. This is only appropriate for a very small number of pupils and the SENDCo and the Cumbria Information, Advice and Support Service will be able to guide you through the process should this be necessary. This assessment could lead to your child getting a Education, Health and Care (EHC) plan. This EHC plan brings all of your child's education, health and social care needs into one legal document. It replaces the previous STATEMENT of SEN from the 2001 code of practice.

How can I help?

At all stages of the SEND process, the school endeavours to keep you, as the parents, fully informed and involved. We take account of your wishes, feelings and knowledge at all stages. If this is at odds with the advice being received by the school we will work to try to bring the two opinions together. If your child is experiencing difficulties, you will be informed either at parents' meetings (autumn and spring terms) or during informal meetings to discuss your child's progress. We will inform you of any outside intervention, and will share the process of decision-making by providing clear information relating to the education of your child. At all stages we encourage you to make an active contribution to your child's education.
